Rigorous testing is conducted in approved Independent test laboratories (ENEC TLs) located worldwide, or in certain cases, in approved manufacturers' laboratories.

Today, around 17,000 certificates covering 80,000 products have been granted the license to display the ENEC mark.

The ENEC mark scope includes:

- luminaires and associated components, LEDs
- · household appliances,
- IT equipment,
- · safety transformers,
- · couplers, connecting devices,
- controls, switches,
- · capacitors, filter
- security equipment.

HOW DOES THE ENEC MARK WORK?

ENEC Mark Scheme procedures constitute a full certification scheme (ISO Type 5).

- Annual factory inspection
- · Ongoing product and production monitoring
- Visible use of ENEC Mark logo on products
